These limitations are also valid for transport contracts with heavy and oversized cargo.

Further limitations arise from the insurance contract as well as from the general insurance conditions for current insurance for the freight forwarder, freight carrier and warehouse liability insurance (ALLKURANZ Schwergut) and / or the current operating description.

Customs and excise duties are subject to special limitations.

The damage caused by a loss event to a number of damaged parties shall be replaced pro rata in the proportion of their claims irrespective of the number of damaged parties and traffic contracts if they together exceed the maximum limit of the insurance benefit.
